We are keen to approach this in a systematic way and are therefore looking to set up a small working group (of 3-4 members) to lead on the development of this strategic plan.

The purpose of the group is to develop a focused QI strategy, with a view to articulating the various strands of quality improvement activity that the Faculty wishes to engage in over next 5 years, and to develop a targeted action plan and deliverables for each strand. The QI strategy working group will be led by the Director of Quality Improvement, Dr Simon Sheard. The main output, a QI strategy document, will be co-ordinated by Dr Sheard, but members of the working group will contribute to its drafting and refinement. The group members will also take a part in mapping the key stakeholders in the occupational health quality agenda, and in helping to engage them in the strategic development. It will be important for members to help with communications with the wider Faculty membership around their needs and aspirations for quality improvement, and the Faculty's role in achieving these.

We envisage this to be a project lasting 6-12 months, with two face-to-face meetings and additional direct contact by email and teleconference.

The role

To provide input and guidance (as a member of the working group) to quality improvement in Occupational Health and Occupational Medicine, with the group aim to;

- develop a plan that will help to improve methods of measuring and assessing quality
 - o for individual occupational health practitioners, to help with appraisal and revalidation
 - for services, to demonstrate quality to their commissioners and clients
- articulate streams of work, and for each stream describe clear goals and a plan of how to achieve them;
- ensure that quality in occupational medicine and occupational health is better understood by our stakeholders, including clients (patients) and commissioners
- report to the Faculty Board
