#### Health and Work Development Unit (HWDU)

The HWDU is a partnership between the Royal College of Physicians and the Faculty of Occupational Medicine. It aims to improve the health of the workforce through the delivery of national quality improvement projects. Using an evidence-based approach, HWDU works with OH services to improve the quality of clinical OH. It also works with organisations to improve implementation of NICE guidance for the workplace and the promotion of good health.

## National audits offer a unique opportunity for all occupational health (OH) providers to focus on clinical quality.

Using robust, piloted, evidence-based tools and methodology you can:

- > measure your current practice

In 2013 the HWDU is opening two audit and quality improvement projects to all OH physicians, nurses and services in all industries throughout the UK.

### National clinical audit of long-term sickness absence

- > Evaluate your clinical performance against guidance from the National Institute for Health and Clinical Excellence (NICE) on management of long-term sickness absence.
- > **Focus** on co-morbid depression, work barriers and enablers, and the use of psychological and physical therapies.
- Collect evidence of compliance with SEQOHS accreditation standards
   C1.3 and G4.1, and revalidation audit requirements.

Between 2008 and 2010 one full cycle of this audit was completed by 82% of NHS OH services in England. In 2010 over 7000 consultations for long-term sickness absence were audited and OH services demonstrated significant improvement in nearly all areas.

## National clinical audit of record keeping standards

- Measure and improve your compliance with regulatory body requirements for clinical record-keeping and benchmark against OH services nationally.
- > Collect evidence of compliance with SEQOHS accreditation standard B1.1.
