Introduction

The launch of the National School of Occupational Health is the result of an exciting and successful collaboration between Health Education England (HEE) and the Faculty of Occupational Medicine. Its launch provides a timely opportunity to review arrangements for education and training in Occupational Medicine nationally. The School will expand over coming months to include the training of other professions involved in the delivery of occupational health services.

These changes form part of an action plan that was submitted to the General Medical Council (GMC) in response to its inspection in 2012 of training arrangements in occupational medicine. The action plan was developed by the Faculty of Occupational Medicine and was accepted by the GMC, giving the Faculty a mandate to implement changes. Subsequently, a proposal to establish the national school for occupational health was accepted by Health Education England.

As a part of the agreed phased approach to the creation of the National School, in the first year the focus is on Occupational Medicine.

The proposed model for the School builds on the existing London/Kent Surrey Sussex School of Occupational Medicine model with close working relationships between the lead Local Education and Training Board hosting the School of Occupational Medicine, Health Education North West London (HENWL), and the Faculty of Occupational Medicine.

The School will be launched in August 2014.

The purpose of the School will be to quality manage the provision of training in occupational medicine in England in order to ensure and assure the interpretation and delivery of the national curriculum for occupational medicine.

The vision of the School's is one of world class training and education in occupational medicine and occupational health to sustain and develop an occupational health workforce for the benefit of working people.

The School will be a national leader promoting

This initiative has already commenced with a single national recruitment process for England, with Wales also participating. Scotland, Northern Ireland and the defence deanery will continue to run their own separate systems for the time being but are keeping a watching brief on these developments.

As we move towards this, we will be engaging with a wide group of stakeholders including Health Education England, the Faculty of Occupational Medicine, Postgraduate Deans, trainers and trainees, providing regular briefings about progress.
