SEQOHS Assessors

The Safe Effective Quality Occupational Health Service (SEQOHS) accreditation scheme is currently recruiting experienced Occupational Physicians, to conduct SEQOHS assessments throughout the United Kingdom.

SEQOHS Assessors are the front line ambassadors of the accreditation scheme, and they are responsible for reviewing the evidence that is submitted by occupational health services in support of their application, and also for conducting site visits.

The ideal SEQOHS Assessor should be:

- actively working within the occupational health profession
- a member of a professional body (GMC)
- able to provide evidence of their commitment to continuous professional development
- able to evaluate submissions against set criteria
- able to meet deadlines and work under reasonable pressure
- have good interpersonal and collaboration skills.

Faculty subscriptions - final reminder

This is a final reminder that subscriptions for membership and revalidation are due by **30 June 2013**. Payment of any outstanding amounts may be made online through the members' area log on.

Please be aware that if you are revalidating through the Faculty and your membership subscription lapses your prescribed connection to the Faculty will end. The Faculty will then no longer be your Designated Body and you will be unable to access the Faculty Responsible Officer.

In order to retain your prescribed connection to the Faculty - and therefore access to the Responsible Officer and associated systems and support - you must pay your outstanding membership subscription and revalidation fee. If full payment is not received by this date your prescribed connection to the Faculty will end and you will be removed from our GMC Connect account.

To pay your annual subscription and revalidation fee, please call the Faculty Finance team on 020 3116 6905 or pay online in the members area of the Faculty website. A membership rejoining fee (£32) will also be payable, should your membership lapse.
