# Multi source feedback for revalidation – questionnaire

We Need Your Help!

The GMC requires all doctors to collect colleague and patient feedback at least once during each revalidation cycle. Whilst they have developed a generic colleague and patient feedback questionnaire, the Faculty has modified the former to create one which will more closely match the needs of Occupational Physicians and those who have prescribed connection with the Faculty for revalidation.

Work is continuing on scoping the possibility of creating a new single organisation for occupational health. We are currently considering the potential form or model that a new organisation could take that would best meet the needs of current and potential members. We are also looking at the financial feasibility of making the change.

This autumn we will consult with members, a process that will include debating the issue at regional meetings and via interactive webinars. We will be making every effort over the coming months to make sure you can express your views and shape the process, well before any significant decisions are taken forward.

We are also setting up a new simple website so that both sets of members can stay informed of the latest developments of the project, which will be launched towards the end of this month.
