Professional Briefing Day: Upper Limb Disorders

On 18 September the Faculty held a half-day training workshop on upper limb

disorders for members. Expertly led by Dr Karen Walker-Bone, Honorary Fellow of the Faculty and the only Occupational Rheumatologist in the country, and Dr Ira Madan, Consultant Occupational Physician, the day started with an overview of upper limb disorders and their physiological symptoms.

There followed a discussion on the assessment of occupational causes and a practical demonstration of how to undertake an examination of neck and shoulders.

Delegates commented that the quality of the presenters made the day particularly stimulating, as well as finding the practical demonstration very useful for their own practice.

Winter conference 'Hidden Disabilities' - 10 December 2013

The Faculty's Winter conference, 'Hidden Disabilities', taking place on 10 December 2013 in Manchester, focuses on lesser-known conditions that affect workers.

The day will feature presentations from a range of eminent speakers, including Professor Else Guthrie on medically unexplained symptoms and Professor Cary Cooper on organisational psychology.

The day will also feature a session on dyslexia from Nicola Newman, a leading advisor on age and disability, as well as Dr Owen Bowden-Jones, Honorary Senior Lecturer at Imperial College London, sharing his wealth of experience on mental health difficulties.

The conference programme has been designed to encourage delegates to participate actively and reflect on areas of practice that they find challenging. There will be two breakout sessions during the day where delegates will receive case studies and worked examples from other renowned presenters, on topics including: cancer; bipolar disorder; alcohol abuse; stress and depression; chronic fatigue syndrome; and diabetes in shift workers.

General Osteopathic Council - call for medical assessors

The General Osteopathic Council ("GOsC") is currently recruiting a new pool of medical assessors for its Fitness to Practise Committees. The role of the medical assessor is to provide advice about the medical significance of evidence before the Committee. Occasionally, medical assessors may also be required to undertake a medical examination of an osteopath, and to produce a medical report for the Committee.

The GOsC has identified a need for practitioners with consultant level expertise (or equivalent) in a number of specialties, including occupational health.

Further information about the recruitment exercise, including a candidate information pack and application forms, is available on the GOsC website.

The closing date for receipt of completed applications is 3 October 2013. Interviews will be held at the GOsC's offices in London on 18 and 19 November 2013.
