# Fit for Work guidance published

The Government's new Fit for Work scheme is being rolled out during 2015. Guidance for employers, employees and GPs has now been published to give information about how the service will operate.

The providers of the service have emphasised that the service will complement, and not replace, existing occupational health services provided by employers.

## Alcohol Health Alliance petition

The Alcohol Health Alliance, run by the Royal College of Physicians, is encouraging people to sign a petition calling for health and nutrional information to be mandatory on alcohol packaging.

The campaign follows a UK-wide survey that found that 83% of people support information on how alcohol can impact on health and 87% support a warning that when pregnant, the safest option is to avoid alcohol completely.

Bill Esterson MP is leading a debate on pregnancy and labelling of alcoholic products in the House of Commons today.
