## Revised SEQOHS standards to be launched

The Faculty of Occupational Medicine will launch its revised SEQOHS standards on 1 April 2015.

Throughout 2014 the Faculty held an extensive consultation process of the standards; thank you to all our members who contributed to the review process through the survey, meetings and other means.

The response rate to the review process indicates the high level of engagement in SEQOHS within our membership and the occupational health community at large.

The consultation is now complete and the new standards are about to be published.

The revised standards will contain some important changes and clarifications and but those familiar with the original standards will find them substantially intact. It will be made clear where the changes are and also there will be a period of grace before units which are currently accredited have to move to the new standards.

Professional Briefing Day: Personality disorder – 29 April 2015

On 29 April, the Faculty will be holding its first professional briefing day of 2015 on personality disorder. This prevalent psychiatric disorder has a major impact on

quality of life and fitness for work, but is often poorly understood and frequently neglected by the medical profession. People with personality disorder are often misdiagnosed or incorrectly treated, leading to difficulties managing their condition.

The day will be run by Dr Frank Gallagher, an occupational physician and Fellow of the Faculty, and Professor Conor Duggan of Nottingham University. It will feature interactive seminar-style lectures on the psychiatric aspects of personality disorder, with a clinical case study to be introduced for discussion.
