HSE Workplace Health Expert Committee (WHEC)

HSE is currently recruiting for a new committee to provide independent expert opinion on all aspects of ill-health that is caused by or made worse by work.

The remit of WHEC will be broad, encompassing chemical and physical hazards, and human, behavioural or organisational factors in the workplace (for example shift work) that lead to physiological and/or psychosocial ill health.

HSE is seeking to recruit a diverse group of scientific and medical experts working at the leading edge of their field and actively advancing knowledge on workplace health from a range of perspectives. Expertise may have been gained through either academic, professional or practitioner routes.

The prize recognises an outstanding innovation, initiative or intervention which has delivered a demonstrable health benefit for a defined working population.

You can read the **reports** submitted by previous winning entries on the website, which gives a flavour of the range of initiatives that have been successful in the past.

The successful applicant will receive a cheque for £500 and an engraved memento. Applicants should be a member of the Faculty of Occupational Medicine (all categories of membership are welcome to apply, including affiliating diplomates).

Entries should be submitted by completing and returning the application form.
