We recently sent a survey to all specialist occupational physicians working in the UK about training and services provided to the NHS throughout their careers.

Thank you to all those who took the time to complete the survey; we received responses from almost 300 members, which is a 56% response rate.

The data from the survey will be published in due course, but will also be used to lobby on behalf of the specialty at meetings with Government, Health Education England and other funding bodies.

Submission of CPD Returns 2014-15

If you participate in the Faculty's paper CPD scheme, the CPD year for 2014-15 will end on Tuesday 31 March. If you submit a paper return, this will need to reach the Faculty by Tuesday 30 June. Please submit forms 1 and 5, which can be downloaded here. We will then issue a certificate to you by email.

As you will be aware, this is the final year that we will accept paper CPD returns. In the future you can upload and reflect upon your CPD using the Faculty's online diary (which forms part of the Faculty's revalidation management system).

If you do not revalidate through the Faculty and do not have a login to the CPD diary, you can request one at CPD@fom.ac.uk. Those members using the diary can self generate a CPD certificate at anytime. Instructions on how to do this can be found in the Help menu, once logged in.

With the advent of revalidation, your CPD forms part of the mandatory evidence you must supply to your appraiser each year and you are not obliged to submit a CPD return to the Faculty or upload your CPD into the Faculty's CPD diary, if you do not revalidate with us. Submissions to the Faculty are very much voluntary, depending upon whether you wish to receive a Faculty certificate. An annual audit will continue to take place on submissions from doctors not revalidating with the Faculty.
