The Winston Churchill Memorial Trust (WCMT) funds British citizens, resident in the UK, to travel overseas to study areas of topical and personal interest.

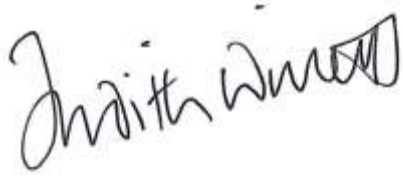
