Changes to external workplace-based assessments

External workplace-based assessments (WBAs) were introduced to enable the Faculty to quality assure the use of WBAs in practice. In 2011 the Faculty received only 23 external WBAs and in 2012, 17.

Following a review of the process and influence of these assessments it has been decided to discontinue them.

Trainee e-portfolio

The Faculty work continues on this. Unfortunately the progress on this has been

arrested as the portfolio was being developed by National Education Scotland (NES) and they have suspended all new development work effectively ending our partnership. The Faculty is now in discussion with alternative providers with a view to development of an e-portfolio for Occupational Medicine.

Clinical audit workshop

Would you like a workshop that will help you to design an audit in a day?

Clinical audit is a technique that can improve patient outcomes by measuring performance against pre-determined standards and acting on the findings. Completion of a full cycle (measurement, intervention, measurement) of clinical audit would meet the criterion of a quality improvement activity for revalidation. It also helps you to achieve curriculum competencies.

The workshop will teach participants how to prioritise audit topics and develop their chosen topic into an effective local clinical audit. By the end of the day participants will have a good understanding of the stages of clinical audit.

If there is sufficient demand the workshop will be run by Dr Siân Williams and Penny Peel from the Health and Work Development Unit (a FOM/RCP partnership) and will be held at the Faculty office.

Courses

Course A: Revision Course for Part 2 MFOM

Following feedback from this year's examinations and the University of Birmingham Revision Course, a revision course is being offered in 2014.

Dates: 5-7 August 2014. Please see booking information below.

Course B: How to assess and manage risks to health from chemical substances in the workplace – a practical course for OH practitioners.

Programme lead – Dr Steven Sadhra, University of Birmingham.

The content of this course is specifically designed to help those who have difficulty accessing occupational hygiene experience. A different course (Noise and vibration, ergonomics, etc) will be run over a 4-year cycle to cover all major

aspects within occupational hygiene. The occupational hygiene / photographic sections of the OSCE within the experience of the new Part 2 MFOM examinations have highlighted deficiencies in candidate knowledge about workplace risk assessments and occupational hygiene.

This is a 2-day practical programme designed to improve knowledge of industrial processes, methods for assessing exposure to chemicals and the interpretation of typical exposure data presented in occupational hygiene reports. The programme will also cover methods used for selecting and evaluating control measures including personal protective equipment (PPE) and engineering ventilation systems. Sampling instrumentation used to collect exposure data will also be available for delegates to handle and become familiar with their use. The use of occupational hygiene data will be discussed in assessing and managing risks in the workplace including health surveillance.

Course C: Two day course on epidemiology and statistics

A two day course on epidemiology and statistics, to be delivered by Dr Hubert Lam, University of Birmingham. Dr Lam leads the teaching of epidemiology and research methods on the MSc in Occupational Health, University of Birmingham.

All three programmes will be designed primarily to meet the needs of specialist trainees in occupational medicine but will be open to all occupational health practitioners.

Work is progressing on the National School of Occupational Medicine which we hope will become a reality next year in a phased manner. Initially there will be centralised recruiting for NHS trainees. The plan is for ARCPs to be co-ordinated for NHS and Industry trainees. The aim is to have more regular ARCPs to ensure that those in smaller Deaneries/LETBs are not disadvantaged with timing.
