## **About us**

FOM is a faculty of the Royal College of Physicians, but operates independently in terms of its governance and finance. FOM sets professional standards and assesses individuals and organisations against those standards, the latter being achieved through the SEQOHS accreditation scheme.

In addition to SEQOHS, FOM activities include setting the curriculum for occupational medicine, providing qualifications for clinical professionals including nurses, supporting doctors to obtain specialist registration with the GMC, revalidation, and delivering an annual scientific conference and other events.

FOM is governed by a Board of Trustees. The Board decides collectively on matters of FOM strategy and policy, and appoints project leads and committees to oversee key aspects of work.

FOM's Chief Executive is appointed by the Board and is responsible for FOM operations, including staffing, finance, contracts, risk management, legal and regulatory compliance, internal processes and procedures. The Chief Executive also supports strategic partnership working and project delivery. There is a senior management team in FOM, and department managers, as well as administrative colleagues working within the departments who work with a large number of volunteers.

Annex 1 shows the positioning of SEQOHS within FOM's organisation structure, and the two new roles of SEQOHS Quality Lead for Assessors and SEQOHS Quality Lead for Accreditation.

## **About SEQOHS 2023**

The SEQOHS Steering Group provides a point of referral for clinical queries arising from SEQOHS activities, and for any proposed changes to SEQOHS policy. The SEQOHS Steering Group also reviews work carried out on the standards review, and any policy change proposals agreed by the SEQOHS Steering Group must also be referred to the

Board for final review and sign off.

The 2023 SEQOHS standards were formally approved by the FOM Board in March 2023.

A review of the evidence guide is the next stage of the process, and this will be done in parallel with the development of IT systems, using a consultative and team-based approach. SEQOHS 2023 is due to go live on 1 November 2023.

SEQOHS Assessors are vital to this process and must be consulted, kept informed, supported and provided with appropriate training and advice, as required. We also need to recruit and support new SEQOHS Assessors.

For services working towards accreditation, or re-accreditation, FOM would like to look at what could be done to reduce administrative burden for services where possible, and lessen the time between registration and outcome. This will be done by designing the SEQOHS 2023 webtool to be as straightforward and clear as possible, and this includes the online evidence guide and creating downloadable templates where possible.

We recognise the need to be flexible in how we support SEQOHS Assessors, as well as services. The format of all training will be adapted to align with the SEQOHS 2023 Standards, and will aim to maximise effectiveness and flexibility. All services engaged with SEQOHS will be asked for their views.
