Faculty Prizes - could you be a winner?

The Wilf Howe Memorial Prize, which is a cheque for £500 and an engraved memento, is awarded in recognition of an outstanding innovation, initiative or intervention which has delivered a demonstrable health benefit for a defined working population. Previous winning entries have included: A cross sectional study of the rates of ill health retirement in four public (fire, police, teaching and ambulance services) and two private (Rover and Post Office) employers; The assessment and validation of acclimatisation to a hot-dry climate in British Armed Forces personnel; Implementing and evaluating a successful condom promotion intervention project for brothel-based sex workers in Singapore; and Identifying and addressing occupational-related skin problems on a chemical industrial site.

The Mobbs Travelling Fellowship offers an opportunity for doctors to travel to a centre of excellence to study a particular aspect of occupational medicine or to travel to a scientific meeting for which they have had a paper or poster accepted. Previous winning entries have included: a visit to Australia to study the Workers' Compensation System; abstracts accepted for the ICOH conference; and a study trip to Hong Kong hospitals affected by the SARS outbreak.

Pilot of externally assessed WBAs update - your views please

A study into the inter-rater reliability between the outcomes of the WBAs undertaken by External Assessors and Educational Supervisors (trainers) was undertaken this summer and feedback will be provided once evaluation is completed. As a result of the initial findings of the study, as well as the WBA training day in September 2010, the current assessment tools are being evaluated, with the main emphasis on SAIL (Sheffield Assessment Instrument for Letters) and DOPS (Directly Observed Procedures), in order to make them more fit for purpose.
